They have, however, been endorsed by other grassroots organizations who uphold medical freedom and informed consent, and/or publically expressed support for parts of our mission, and/or voted against HB3063 in 2019. HB3063 sought to remove the ability of a parent to opt out of vaccines for their children via non-medical exemptions

Recommended:

Christine Drazan

✓ In 2019, she publicly opposed and voted against HB3063 (see details above).

✓ She voiced opposition to forced COVID-19 vaccines for adults and mask mandates.

✓ In 2022, she requested HJR 206 which sought to limit gubernatorial emergency powers.

Recommended with Reservations:

Betsy Johnson

✓ In 2019, she publicly opposed HB3063 (see details above). She also voted against it in a committee work session.

✓ She voiced opposition to forced COVID-19 vaccines for adults and mask mandates.

✓ During 2021 and 2022, multiple bills to halt the government's infringement on our medical freedoms were put forward by other senators (such as SB872 and SR2). She voted against sending SB872 and SR2 to the floor for a vote, and the bills died in committee.
